ABOUT US

IPT is a Lebanese Family Business established by Michel Issa in the seventies specialized in the import, storage and distribution of petroleum products mainly gasoline, diesel oil, lubricants, and LPG serving hundreds of gas stations, factories, and homes. IPT boasts a network of 200 service stations in Lebanon, owned & managed by the company as well as franchised stations, spread across the country. Today, IPT is a success story that brings to the forefront more than five decades of experience in the energy sector.

In 2021, IPT entered a new stage of development in the region and chose the UAE as the hub for its activities abroad. This step reaffirms the resilience of IPT despite the difficult times Lebanon underwent since 2019. IPT has held its place in the country and expanded its activity throughout the region.

To this end, IPT has launched IPT Energy DMCC, which specializes in trading refined oil products, and it complements its activity with lubricants and petroleum equipment. At a later stage, IPT Energy DMCC plans to enter the market for renewables.

In parallel, IPT ENERGY entity will also be operating locally within the UAE, specializing in diesel distribution, bunkering, lubricants and fuel-oil supply services. To this end, IPT has acquired a storage facility in Sharjah for the storage of diesel and fuel oil. It owns its own fleet ready to distribute B2B across the Emirates.

To this end, IPT cooperates with major UAE companies to secure the supply of petroleum products necessary for its activities.

IPT also distinguishes itself with a strong partnership with the energy giant Total Energies, signing a framework agreement for a long-term partnership. The first step of its partnership is Total Energies UAE appointing IPT an authorized distributor of Total Lubricants, high quality engine oils.

DGO (Diesel Gas Oil)

We supply premium quality, low sulfur automotive diesel fuel or high-speed diesel-powered engines, generator sets and other industrial applications.

Our 10 parts per million (ppm), low Sulfur diesel follows the latest international requirements in environmental and quality standards and complies with the Emirates Authority for Standards & Metrology (ESMA) UAE.S 477:2013 diesel (Gas Oil) specifications.

Product Quality & Supply Reliability

- Storage facility in our terminal located in Sharjah to ensure flexible and secure product supply.
- Distribution fleet fitted with GPS tracking to monitor around the clock, ensuring security and timeliness of deliveries.
- Digital fuel monitoring system of tanks and fleet linked to a centralized control room.
- Meters are constantly calibrated by third party to ensure accuracy of supply on every delivery.
- Continuous sampling and lab testing of our products to ensure they are in accordance with the specifications.
- Quality assurance as we follow the latest international requirements of the Emirates Conformity Assessment System (ECAS) based on compliance of Emirates Authority for Standards & Metrology (ESMA) UAE.S 477:2013 diesel (Gas Oil) specifications.
- This framework holds particular importance in strengthening the long-standing relationship between IPT and TotalEnergies which has proved successful in Lebanon and is now ready to take on new opportunities together in the region.

Health & Safety Expertise

- Our Terminal is equipped with a continuously pressurized firefighting system. Whenever a sprinkler is heated up, it breaks and water is released which leads to a pressure drop that turns on our 1250 GPM pumping system. So, in case of fire, no human intervention is required until the civil defense's arrival as our system would be operating automatically.
- Our tanks are equipped with foam chambers to eliminate the fuel-air contact, water rings to cool the nearby tanks and water monitors in case of fire outside the tanks area.
- Our terminal operators have been trained to correctly respond and behave in case of emergencies including fires, earthquakes, accidents and injuries that require first aid. To ensure the capability and readiness of our staff at all times, surprise maneuvers and drills are being frequently undertaken on site.

Since 2013, IPT Quality Management System has been certified to ISO 9001:2008 covering the scope of: "IMPORT, EXPORT, STORAGE & DISTRIBUTION OF PETROLEUM PRODUCTS AND INSTALLATION & MAINTENANCE OF PETROLEUM EQUIPMENT".

In 2018, IPT successfully upgraded its ISO 9001 certification from version 2008 to 2015 continuously until now.

IPT Energy Expands in the Region, First Stop UAE


IPT enters a new stage of development in the region, and the first stop of its expansion is the UAE.
